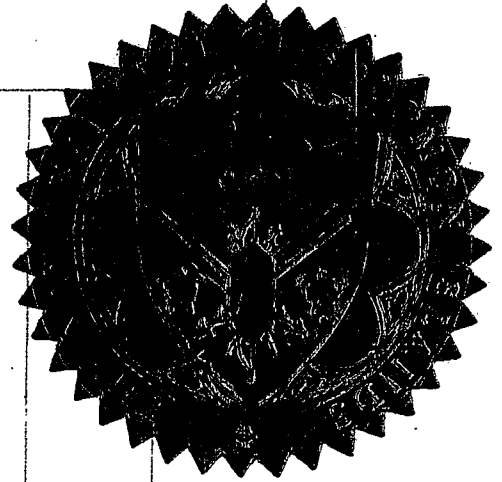



AN ACT to amend the Forests Resources and Timber Utilisation Act.

ENACTED by the National Parliament of Solomon Islands.

1. This Act may be cited as the Forests Resources and Timber Utilisation (Amendment) Act 1987 and shall be deemed to have come into operation on 13th January, 1978.

2. Subsection (1) of section 5B of the Forests Resources and Timber Utilisation Act is amended as follows -

- (a) by substituting the expression "who wants to carry" for the word "carrying"; and
- (b) by inserting the word "and" immediately before the expression "who wishes".
