

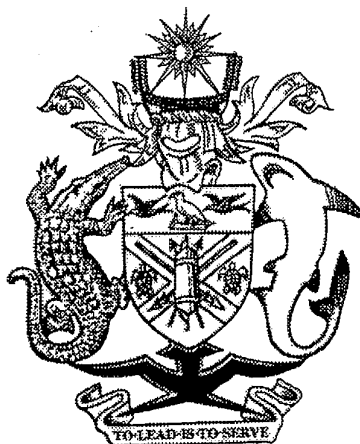

COLLEGE OF HIGHER EDUCATION (AMENDMENT) ACT 2008

Short title

1. This Act may be cited as the College of Higher Education (Amendment) Act 2008.

Section 4 amended

2. Section 4 of the principal Act is amended –

(a) in subsection (1) –

(i) by deleting “and” at the end of paragraph (f);

(ii) by deleting the full stop at the end of paragraph (g) and substituting “; ”;

(iii) by adding the following paragraphs –

“(h) the School of Tourism and Hospitality; and

(i) any other School declared by the Minister by order in the Gazette, on the advice of the Council.”

(b) by adding the following subsection –

“(1A) The power of the Minister under subsection (1)(i), includes the power to add, delete or merge schools set out in subsection (1).”.
