The Business Name Bill 2014 (the Bill) is proposed as part of the Government's ongoing program of reforming business laws to bring them into line with modern best practice and the conditions of business in Solomon Islands. It modernises the regulatory process concerning registration of business names. It ensures business efficiency and enhances compliance requirements.

The Committee acknowledges and appreciates the Asian Development Bank, New Zealand Aid, and Australian Aid for facilitating these ongoing reforms to the business laws in this country.

In addition, the Committee encourages the Solomon Islands Government to proactively approach such reforms by offering a complete package to aid donors so that reformation to other relevant regime or framework is carried out simultaneously without the need to approach the reforms on a piecemeal basis.

The Committee recommends this Bill to the House.

#### 1. INTRODUCTION

The Bills and Legislation Committee ("the Committee") reviewed the **Business Names Bill 2014 (No.11 of 2014)** on the 7<sup>th</sup> May 2014. The Bill was submitted on the 30<sup>th</sup> April 2014 to the Speaker of the National Parliament, through the Clerk to Parliament, as required under the *Standing Orders*<sup>1</sup>.

The Committee deliberated on Friday 2<sup>nd</sup> May and resolved to invite relevant stakeholders<sup>2</sup> to appear before the Committee and make presentations on the contents, policy matters, and intentions of the Bill. The hearing was held on the 7<sup>th</sup> May 2014. The minutes of these proceedings are in Appendix 1.

#### 1.1 Functions of the Committee

The Bills and Legislation Committee is established under the *Standing Orders*<sup>3</sup>. The Order made pursuant to the *Constitution*<sup>4</sup> has the functions together with the necessary powers to discharge such, to:

- (a) examine such matters as may be referred to it by Parliament or the Government;
- (b) review all draft legislation prepared for introduction into Parliament;
- (c) examine all subsidiary legislation made under any Act so as to ensure compliance with the Acts under which they are made;
- (d) monitor all motions adopted by Parliament which require legislative action;
- (e) review current or proposed legislative measures to the extent it deems necessary;
- (f) examine such other matters in relation to legislation that, in the opinion of the Committee require examination; and
- (g) make a written report to each Meeting of Parliament containing the observations and recommendations arising from the Committee's deliberations.

### 1.2 Term of Reference

Pursuant to its mandate under the *Standing Orders*<sup>5</sup>, the terms of reference of the Committee in this instance is to review the Bill and to report its observations and recommendations on the Bill to Parliament.

#### 2 BACKGROUND

The Bill is designed to repeal and replace the *Registration of Business Names Act* [Cap.178] (the Act). It will regulate the application for, issuance and recording of business names as well as provide for appropriate penalties for non-compliance.

Currently, the Act regulates the registration of firms, individuals, and corporations carrying on business under a business name. It was enacted on the 1st July 1971 and adopted in 1978. It is archaic and is becoming ineffective.

#### 3 THE BILL

The Bill ensures that, if an entity carries on a business under a business name, those who engage or propose to engage with that business can identify and contact the entity. It also ensures that business names that are the same or almost the same as other business names, or the registered names of companies, charitable trusts or co-operative societies, are not used where that would confuse or mislead the public. Finally, the Bill ensures that business names that should not be used, including because they are misleading, deceptive or offensive to the public, are not used.

The Bill requires individuals, bodies corporate, bodies politic, partnerships and unincorporated association or bodies of person to register business names if they are using a business name. It specifies the information to be kept on the Register. It prohibits certain names from being registered except in specific circumstances. The Bill outlines the obligations that come with having a registered business name. It provides the Registrar with better powers to maintain the Register. It outlines offences and associated penalties.

An innovative feature of the Bill is that the responsible Ministry will be able to upgrade the existing paper-based Business Names Registry to an electronic database.

#### 4 OBSERVATIONS

The following are the Committee's observations regarding the Bill.

## 4.1 Exposure of business information

The Committee is concerned that, given the lack of an internet security policy, on-line registrations of business names exposes business information and is prone to cyber intrusions.

#### 4.2 Filing of returns

The Committee noted that the Act requires an entity to furnish the Registrar of changes to an entity's particulars twenty-eight days within twenty-eight days of the change(s). The Bill requires an entity to file a return every two years in relation to the registration.

The Committee is adamant that filing of returns can be done on-line as well.

#### 4.3 Online payments

The Committee is concerned of the option available to make online payments of the prescribed fees under the Bill.

#### 5 RECOMMENDATIONS

At the conclusion of the hearing and based on the evidences collected at the hearing, the Committee makes the following recommendations –

#### **Recommendation 1**

The Committee recommends that the Government expedites its business laws reform program to ensure ease of doing business in Solomon Islands.

#### **Recommendation 2**

The Committee recommends that the Government formulates and implements an internet security policy to safeguard business information.

#### **Recommendation 3**

The Committee recommends that customers are given the option to make or file returns electronically.

#### **Recommendation 4**

The Committee recommends that customers are given the option to make payment of prescribed fees electronically.
