1. This Act may be cited as the College of Higher Education (Amendment) Act 2008.

- 2. Section 4 of the principal Act is amended
 - (a) in subsection (1)
 - (i) by deleting "and" at the end of paragraph (f);
 - (ii) by deleting the full stop at the end of paragraph (g) and substituting "; ";
